

2016-2017 Tuition Schedule for St. Francis Catholic School

There are four tuition plans available: "Total Cost", "Catholic Tuition", "Parishioner's Subsidized Tuition", and "Unsubsidized". Each plan has three payment options: one payment in full - which includes a 1% discount*, four payments made quarterly, or 10 equal payments. Please review and select the option that best suits your ability to fund your child's education.

This option includes a tax-deductible donation of \$2,722 for parishioners and \$1,322 for non-parishioners.

Parishioners who select this option forgo the subsidy from the parish. Share hours are not required of parents who select this option.

In order to apply for this tuition rate the child attending school needs to be baptized Catholic. There is a tax-deductible contribution of \$1,020.00 in this plan for families that qualify for the parish subsidy and elect to forgo the subsidy by paying the Catholic Tuition rate. Share hours are required.

There is no tax-deduction in this plan: however, any amount paid above tuition is a tax-deductible donation.

Parishioners who opt for this plan take advantage of both a parish subsidy and a fundraising allowance. Share hours are required.

Non-Catholics are required to pay this tuition. Each qualifying Parish or Catholic family is encouraged to pay the unsubsidized tuition rate, which will assist the school in its efforts to bridge the tuition gap while also providing critical tuition assistance to students in need. This option includes a tax-deductible donation in the amount of \$1,450.00 for parishioners that qualify for the parish subsidy and a donation amount of \$430.00 for families that qualify for the Catholic tuition rate. Share hours are required.

*Any tuition plan paid in full by September 6th, 2016 receives a 1% discount.
