I hereby irrevocably grant the Diocese, perpetually and exclusively, the right to use and incorporate (alone or together with other materials), in whole or in part, the Property, in any Diocesan publication, website, press release or other publicity medium, advertisement, virtual, remote or electronic video conferencing, or for any other Diocesan purpose (which may include publication in non-Diocesan mediums). Further, I hereby authorize the reproduction, sale, lease, copyright, exhibition, broadcast and/or distribution of the Property without limitation for any lawful purpose whatsoever. This release shall not, however, obligate the Diocese to use the Property or to use any of the rights granted hereunder, or to exhibit, distribute, or exploit the Property.
