- In the event the tax credit limit has been reached when this gift is received, your gift will be promptly returned.
- If you have set up a recurring gift, your consolidated receipt will be mailed at the end of the calendar year.

It is important to note that donor requested restrictions to specific school(s)/system(s) are subject to the following STO regulations. IMPORTANT REMINDERS

- If sending your contribution after October 1, 2019
 please check the website or call to see if credits are
 available. Credits are limited and awarded on a first
 come, first served basis.
- IRA and stock contributions **must be made on or before December 1, 2019** (assuming tax credits avail.).
- To qualify as a Qualified Charitable Distribution (QCD) that satisfies your RMD requirement, you must be 70½ at the time the gift is made.

Stock Contributions

A contribution of common stock to the STO program is a win-win situation. Please follow the steps below to insure that your contribution of stock is received and applied correctly. **Before initiating a stock transfer please verify with our office at (563) 556-2580 ext. 219 that tax credits are still available.** Failure to submit both the stock form below and the STO donor form may result in ineligibility for the lowa Tax Credit.

- If the form below and the STO Donor Form are not received within 14 days of the stock transfer your gift may not be eligible for an lowa Tax Credit. Please contact Jeff Schneider at Jeff.Schneider@DbqArch.org or (563) 556-2580 ext. 219 with questions.
