- Tax credits are awarded on a first come, first served basis.
- Contributions must be postmarked by **12/31/20** to be eligible for a 2020 tax credit.
- In the event the tax credit limit has been reached when this gift is received, your gift will be promptly returned.
- If you have set up a recurring gift, your consolidated receipt will be mailed at the end of the calendar year.

It is important to note that donor requested restrictions to specific school(s)/system(s) are subject to the following STO regulations. Up to 50% of gifts may be restricted to school(s)/system(s) as designated. The Contributor understands and agrees that if a school/system designated for a restricted contribution does not have one or more students who are eligible to receive tuition assistance under the law's requirements or all eligible students have received the maximum assistance set by the STO board so as to permit for the full use of the requested contribution, the contribution, or the unused portion thereof, will be used for tuition assistance for qualifying students at any of the STO schools/systems. - If sending your contribution after October 1, 2020 **please check the website or call to see if credits are available.** Credits are limited and awarded on a first come, first served basis.
- IRA and stock contributions **must be made on or before December 15, 2020** (assuming credits avail.).
- To qualify as a Qualified Charitable Distribution (QCD) that satisfies your RMD requirement, you must be 70½ at the time the gift is made.

Stock Contributions

A contribution of common stock to the STO program is a win-win situation. Please follow the steps below to insure that your contribution of stock is received and applied correctly. **If initiating a stock transfer after October 1st, please verify with our office at (563) 556-2580 ext. 219 that tax credits are still available.** Failure to submit both the stock form below and the STO donor form may result in ineligibility for the Iowa Tax Credit.
