Tuition Plans and Fee Policies for 2020-2021

TUITION PLAN A

For active and practicing Catholic families who also participate fully in our Gift Card Program:

One child: \$ 3200 (\$ 266.67/month)	Two children: \$ 5650 (\$ 470.83/month)	Three or more children: \$ 8100 (\$ 675.00/month)

“Active and practicing Catholic families” are those who attend Mass regularly and contribute at least \$10.00 weekly in the Sunday offertory (annual total of \$500 in offertory from January 1 to December 31). Active and practicing Catholic families qualify for this lower tuition plan based on contributions to Sunday offertory and from our Education Foundation (approximately \$2,700 in scholarship aid per child).

St. Charles Parish offers the Gift Certificate Program for those who choose to participate. It is a scholarship aid fund-raiser. School families should purchase a minimum of \$5000 per year (January 1 to December 31) in order to qualify for Tuition Plan A. Encourage your family, friends, and neighbors to participate and give your family credit.

TUITION PLAN B

For those families who do contribute to the Sunday offering at Saint Charles but choose not to participate in the Gift Card Program:

One child: \$3450 (\$ 287.50/month)	Two children: \$5,900 (\$ 491.67/month)	Three or more children: \$8350 (\$ 695.84/month)

TUITION PLAN C

For those not attending Mass, not using offertory envelopes totaling \$500 per year, and not participating in the Gift Certificate Program – the full cost to educate a child at Saint Charles School:

\$5550 per child
(\$ 462.50/month)

TUITION POLICIES

- ✓ There are no school sponsored fund-raisers involving St. Charles students. There is no book fee, playground fee, technology fee or library fee.
- ✓ A student is considered registered (or re-registered) for the upcoming school year when a **\$25 non-refundable registration fee per child** (maximum \$75 per family) and a completed registration form is received by the School Office. Academic performance will be a consideration for acceptance for the next school year.
- ✓ Only families who are current on tuition balance for the 2019-20 school year may re-register for the 2020-2021 school year.
- ✓ All families are required either to pay in full by May 31, have the tuition amount automatically deducted, or charged to a credit card. Regardless of payment choice, a Tuition Withdrawal Form is required each year from each family.
- ✓ A 5% discount will be given if tuition is paid in full by May 31, 2019.
- ✓ The School and Parish Business Office reserve the right to withhold transcripts, report cards, diplomas, and student seat assignments until all financial obligations are met.

Tuition Monthly Payment Plans for 2020-2021

Tuition Plan A: For active and practicing Catholic families who contribute annually to the collection at Mass (\$500 annually) and fully participate in the Gift Certificate Program (\$5000 annually at minimum).

One Child:	\$3200	\$266.67/month
Two Children:	\$5650	\$470.83/month
Three Children:	\$8100	\$675.00/month

Tuition Plan B: For those Catholic families who attend Mass regularly (contributions annually = \$500), but choose not to participate in the Gift Certificate Program.

One Child:	\$3450	\$287.50/month
Two Children:	\$5900	\$491.67/month
Three Children:	\$8350	\$695.84/month

Tuition Plan C: For those not attending Mass, not using offertory envelopes totaling \$500 per year, and not participating in the Gift Certificate Program (annually \$5000 at minimum). This is the actual cost to educate a child at Saint Charles Borromeo Parish School.
