Please complete this form to ensure the proper transportation for the upcoming school year. The Perkiomen Valley School District requires to show two proofs of residence along with this document (examples are Real Estate Tax Bill, Current PA Driver's License; or Utility Bill), all showing the address of residency.

The form is to be submitted each year before the end of JULY or transportation cannot be guaranteed for the start of school. Submit this form to the attending school or to the Perkiomen Valley School District Office, located at 3 Iron Bridge Drive, Collegeville. If submitted during the school year, the attending school will contact the parent with the start date and bus information once the request has been approved and the transportation is in order. This request **EXPIRES** at the end of each school year.

Non-Public Residence Verification

The Perkiomen Valley School District requires verification of residence of students requesting transportation services. This includes new students to our district and students who have had a change of address at any time throughout the current school year.

Please provide two of the following documents showing the address at which the parents/guardians reside on a continuous, permanent basis. If the necessary documents are not with the request for transportation, your child will not be considered eligible for services and transportation will not be provided until requested documentation is received.

Verification Documentation

- Real Estate Tax Bill (for those residents that have owned residence in district for 5 years)
- Driver's License (the license shall bear the address at which student will reside on a continuous, permanent basis)
- Utility bills (recent monthly bills shall bear the address at which the student will reside on a continuous, permanent basis)
- Any reasonable documentation to support residency within the Perkiomen Valley School District

Failure to inform the Perkiomen Valley School District could result in your responsibility for, but not limited to, transportation costs, legal costs, court costs and administrative costs.

The school district may conduct neighborhood observations on a random basis throughout the year to verify compliance with the conditions of residency. Should it be determined that all conditions of the affidavit are not met, the below parent/guardian signatures shall be liable to reimburse the Perkiomen Valley School District for, but not limited to, transportation costs, legal costs, court costs and administrative costs.
