This spring, students in grades 5-8 will have the opportunity to participate in an after school sports program. The sports being offered are **basketball on Mondays, volleyball on Tuesdays and soccer on Wednesdays**. This program will run after school from **3:10 pm - 4:45 pm**. Any student not picked up by 5 pm will be sent to after care and parents will be charged accordingly. Students are encouraged to wear their gym uniforms. If their gym uniforms don't fit, students can wear an athletic t-shirt and shorts appropriate for school (no offensive graphics or language allowed). Athletic shoes are required, rubber cleats are permitted for soccer but not required. Masks must be worn whenever a student is not actively participating. We will be following Ohio's responsible restart plan for sports, this can be found on our website at olmc-cleveland.org/athletics

What each session will look like will largely depend on how many students show up to play. The intent is to start with a warm up and run drills for the first half and then have scrimmages/game scenarios for the second half. This program will be for students to improve skills in the sports that they love but also to have fun. Sessions will be laid back but we hope to foster a competitive environment and increase interest in CYO sports for next fall and winter. Boys and girls will attend the same sessions but will be split up by gender during the session, as long as there are enough boys and girls to do so. Basketball and volleyball will be held in our gym and soccer will be held on our soccer field. Soccer may be canceled due to rain.

This program will start **April 26th** and go to the end of the school year. It will be run by John Reynolds, the school's Athletic Director, with help from Father Joseph. If you have any questions about this program please contact John Reynolds at reynoldsj@olmc-cleveland.org

To the fullest extent allowed by law, I, on behalf of myself, my spouse, my minor child, as well as our respective heirs and assigns, executors, all other legal representatives and any others claiming through us or on behalf of us, hereby agree to release, discharge, hold harmless and indemnify Our Lady of Mount Carmel Parish Church, Our Lady of Mount Carmel Catholic School and the Roman Catholic Diocese of Cleveland, and the Bishop of the Roman Catholic Diocese of Cleveland, as well as their respective clergy, officers, employees, agents, representatives, attorneys, sponsors and volunteers from and against all claims, judgments, liability (of any nature or extent) which in any way arise out of or relate to my child's participation in this program, whether foreseen or unforeseen, regardless of the cause (including, but not limited to, the negligence of any person).

I understand that it is my responsibility to carry appropriate medical insurance for my child and that such is not the responsibility of any other person or party, including, without limitation, Our Lady of Mount Carmel Parish Church, Our Lady of Mount Carmel Catholic School and the Roman Catholic Diocese of Cleveland.

I have read and fully understand the contents of this entire document and consent to the provisions therein. I fully understand what is involved in this program and I understand that I have the opportunity to contact the program facilitators and ask them about it. I also understand that my daughter/son will abide by the policies and provisions of the Our Lady of Mount Carmel School 2020-2021 Home and School-Family Handbook.

Our Lady of Mount Carmel Catholic School will only accept this permission slip as authorization for your child to participate in this activity. Written notes, altered permission slips, faxes, emails, phone calls, etc. will not be accepted.
