# ALCOHOL POLICY

If the renter wishes to serve beer and wine, the renter must obtain at their own expense a 24 hour beer and wine permit through the New York State liquor authority and provide a copy of it to the Church. The renter must also provide a certificate of general liability insurance (at minimum limits of \$1,000,000 per occurrence, \$2,000,000 general aggregate) including host liquor liability coverage that names Our Lady of the Angels R. C. Church and the Diocese of Buffalo as additional Insured with respect to rental of the Church facilities.

If the renter wishes to serve alcoholic beverages, in addition to beer and wine, they MUST hire a caterer with a liquor license. The caterer must provide a certificate of general liability insurance at the same \$1,000,000 per occurrence and \$2,000,000 general aggregate limits. In addition, the caterer must provide proof of having liquor liability insurance at limits not less than \$1,000,000 per occurrence and \$1,000,000 aggregate. For both coverages, Our Lady of the Angels R. C. Church and the Diocese of Buffalo must be named as additional insured.

**WITHOUT THE NECESSARY PERMITS AND INSURANCE ALCOHOL CANNOT BE SERVED ON CHURCH PROPERTY.**

## ASSUMPTION OF THE RISK AND INDEMNITY AGREEMENT

As renters of Our Lady of the Angels R.C. Church property, we agree to protect, indemnify and hold harmless Our Lady of the Angels R.C. Church and the Diocese of Buffalo from any and all loss, cost, damage or expense, arising out of or from any accident or other occurrence on or about these premises, causing injury to any person or property, and will protect, indemnify and hold harmless Our Lady of the Angels R.C. Church and the Diocese of Buffalo from any and all claims, cost or expense arising from any failure of the renter in any respect to comply with and perform all requirements and provisions agreed to and required by law or ordinance, during the rental period.

Should any alcohol be served by us, we as renters, hold harmless Our Lady of the Angels R.C. Church and the Diocese of Buffalo from any and all loss, cost, damage, expense, injury, or fatality caused to any party, first or third, resulting from the use of alcohol supplied by us. Further, the renter warrants that the above type of activity will be conducted in full compliance with all federal, state and local laws, rules and regulations and in compliance with all rules and regulations of Our Lady of the Angels R.C. Church and the Diocese of Buffalo.
