Update on Assisted Suicide Florida Stakeholder Group, Coalition in Opposition to PAS September 8, 2020

1. The Zoom Presentation included 7 talking points (abridged): (a) ***‘It’s my decision’*** depression, hopelessness and other underlying conditions are the main drivers of suicidal thoughts. (b) ***“I don’t want to suffer”*** Loss of autonomy, loss of dignity and concerns over being a burden... (c) ***“It’s my choice”*** “profit-driven insurance companies have economic incentive to deny expensive lifesaving treatment...” (d) ***“I want a peaceful, dignified death”*** Authentic palliative and hospice care provide extensive support and pain management... (e) ***“The vulnerable and elderly are protected”*** Under Assisted suicide laws, abusers can witness a request for lethal drugs... (f) ***“The medical community supports this”*** Assisted suicide laws circumvent primary care physicians and mental health professional due to lack of support... (g) ***“I’m terminally ill”*** Diabetes, arthritis and complications from a fall are all terminal illnesses... the legal definition of ‘Terminally ill’ under assisted suicide laws is too broad as to be meaningless.
