"Keeping Kids Safe" Diocesan Mandated Safe Environment Program for RE Students

In October all students are required to receive KKS instruction from their respective RE teacher. We strongly recommend that your child(ren) attend class when the instruction is given. You will be notified by email of the dates and given the opportunity to accept or decline this instruction. If you decline, then you are required to sign the opt-out form at the back of this registration packet and return it to Holy Trinity parish before October 1st. Any students without an opt-out form that show up for class will receive instruction.
