Tuition Assistance

Archdiocesan Parishioner Grant (formerly known as the Catholic Grant):

The Archdiocesan Parishioner Grant is a form of tuition assistance intended as an offset of the sacrifices made by active Catholic families to support their Archdiocese of Washington parishes. In order to qualify for the grant, each of the following conditions must apply and be certified on an annual basis:

- Student has Catholic baptismal certificate; and
- Family is registered, contributing, and active in a Catholic parish of the Archdiocese of Washington; and
- A form from your pastor has been submitted, confirming that you are an active, registered and contributing member.

Financial-Need Awards:

- Parents must submit a timely and complete TADS Financial Aid application in order to qualify for any tuition assistance
- Archdiocese of Washington awards average about 15% of calculated need, based on the TADS application
- Archdiocesan financial-aid awards are applied toward, and not in addition to, any SJA awards
- SJA provides additional tuition assistance for families with one or more enrolled children, based on calculated need
- Families with one enrolled child are eligible for up to a 33% reduction in tuition, depending on calculated need
- Families with multiple children enrolled will receive a **minimum** of 17.5% reduction on the second child, 35% reduction on the third child, and 100% reduction for the fourth or greater child, with larger reductions applied based on calculated need

BOOST Scholarship:

- Tuition assistance from the State of Maryland for private-school students with significant financial need
- Application is via Md. Dept of Education website in early spring

Student and Family Fees

Fees are incorporated into the family's tuition-payment plan.

Montessori Toddler through Grade Eight

Per Student Fees:

Instructional materials fee: \$260.00

Includes textbooks and all instructional materials; library books, materials, and software; computer hardware and software; art, music, and P.E. program equipment/materials; and materials for Montessori classrooms and Atrium

Student fee: \$40.00

Includes services provided and assessed by the Archdiocese of Washington

Parents' Association Dues \$50.00

Campus Renovation Fee \$300.00

Tuition Payment Policies

- Tuition may be paid annually, semi-annually, or on a 12-month pay schedule (June-May).
- Annual payments are due in June, semi-annual payments in December.
- Monthly payments may be made on either the 5th or the 15th of the month. A \$29 late fee will be assessed after 10 days.

Volunteer Requirement

All families with children in Montessori Primary through 8th Grade are obligated to volunteer 10 hours per semester. Families may opt out of this by paying \$100.00 per semester.

Fundraisers

St. Jerome Academy fills the gap between tuition income and the cost of operating the school with a combination of fundraisers, contributions & donations, and grants. Families with children in Montessori Primary through 8th Grade are obligated to participate in fundraising activities, but may opt out by paying \$500.00 per school year.
