I attest that I am competent to sign this release and have the right to grant these permissions. I have read this release and am fully aware of its contents.

MEDIA RELEASE:

I hereby grant the WARM, an Ohio Non-Profit Corporation, its assigns, designees, licensees and agents the IRREVOCABLE, PERPETUAL, ROYALTY-FREE, NON-EXCLUSIVE, WORLDWIDE right to my name, picture, video footage, voice, words, and audio (hereinafter the “Content”) in all forms and in all media now in existence or developed in the future and in all manners, to include promotional efforts, dissemination to publishers and/or media outlets, or for any other lawful purposes.

I further release and absolve WARM, its assigns, designees, licensees and agents from any liability resulting from any use of the content or works derived therefrom. It is expressly agreed that WARM is under no obligation to use the Content for any purpose whatsoever.

LIABILITY WAIVER:

WARM appreciates and thanks you for your volunteer service to WARM and its mission to lift up those in need in the Westerville community.

This is an Agreement wherein you agree to waive certain rights and release WARM of all liability volunteering in any of WARM’s operations or programs, at any location where such activities occur.

This Release and Waiver of Liability (“Release”) executed in favor of the WARM an Ohio non-profit corporation, its directors, officers, employees, and agents (collectively, “WARM”).

Whereas the Volunteer desires to volunteer for WARM and engage in the activities related to being a volunteer (the “Activities”). The volunteer acknowledges that the activities may be a risk of setous bodily injury or death.

Accordingly, The Volunteer hereby freely, voluntarily, and without duress executes this Release and Waiver, according to the following terms:

Release and Waiver: Volunteer does hereby release and forever discharge and hold harmless WARM and it successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer’s Activities with WARM.

Volunteer understands that this Release discharges WARM from any liability or claim that the Volunteer may have against WARM with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer’s Activities with WARM, whether caused by the negligence of WARM or its officers, directors, employees, or agents or otherwise. Volunteer also understands that WARM does not assume any responsibility for or obligation to provide financial compensation, assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment: Volunteer does hereby release and forever discharge WARM from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with WARM.

Assumption of the Risk: The Volunteer understands that the Activities include work that may possibly be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from WARM premises and other sites in Westerville and central Ohio. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases WARM from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by WARM in writing, WARM does not carry or maintain health, medical, or disability insurance for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Other: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that this Release shall be governed by and interpreted in accordance with the laws of the State of Ohio. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

I attest that I am at least eighteen (18) years old, competent to sign this consent and release and have the right to grant these permissions. I have read this release and am fully aware of its contents. I agree that this release shall bind me, my legal representatives, heirs, and assigns.
