Background Information and Rationale:

As found in BBD (LOCAL) the Board President is required to announce board members continuing education status at the last regular meeting before the trustee elections (even if an election is not scheduled or held). This report must reflect whether each board member meets or is deficient in the continuing education requirements and must be posted online.

This announcement must include the following:

1. Has completed the required continuing education;
2. Has exceeded the required continuing education; and
3. Is deficient in meeting the required continuing education.

There are four tiers or categories of board member continuing education:

- Tier 1 (Local district orientation, orientation to the Texas Education Code and Legislative updates after legislation session)
- Tier 2 (Teambuilding/3hours each year)
- Tier 3 (Annual continuing education/10 hours first year on board and 5 years each year after)
- Tier 4 (Evaluating student academic performance [SB 1566]/3 hours every 2 years)

The timeframe of continuing education to count for this report is January 1, 2019 to December 12, 2019. The following board members **meets the yearly requirements** for continuing education credit:

- ✓ **Jan Mostella:** (Tier 1/3 hours; Tier 2/3 hours; Tier 3/20.5 hours; Tier 4/completed 2018)
- ✓ **Billy Lerma:** (Tier 1/3 hours; Tier 2/3 hours; Tier 3/5 hours; Tier 4/completed 2018)

The following board members exceed the required 11-hours of continuing education credit for the timeframe of January 1, 2019 to December 12, 2019.

- ✓ **Paul Mostella:** 19.50 hours beyond
- ✓ **Felix Landin:** 7.00 hours beyond
- ✓ **Jan Mostella:** 15.50 hours beyond
- ✓ **Stephen Hoelscher:** 6.50 hours beyond
