AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Vashon Maury Park and Recreation District from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Payroll – wage recalculation, leave usage, and data transfer from payroll system to general ledger
- Cash receipting – Vashon Pool
- Procurement – emergency exemptions

INFORMATION ABOUT THE DISTRICT

The Vashon Maury Park and Recreation District was created in 1983 to operate a system of park and recreation facilities within the District. The District operates 18 parks, multiple community meeting facilities, a lighthouse leased from the federal government, three lodging facilities and multiple recreation facilities. The District has a lease agreement with the Vashon Island School District for the operations and maintenance of the pool, skate park and sports field.

An elected, five-member Board of Commissioners governs the District. Board Members serve staggered, four-year terms. For the fiscal years 2016 and 2017, the District had annual revenue of approximately \$1.5 and \$1.6 million, respectively.
