

TUITION ASSISTANCE

THE NAZARETH ACADEMY TUITION ASSISTANCE PROGRAM is funded by an endowed scholarship fund and patrons of the school. **Tuition assistance is considered a loan by the Sisters that may be repaid at some future time by contributing to the Scholarship Fund to help other students who would be unable to attend Nazareth Academy without tuition assistance.**

Tuition assistance is based on financial need and is granted for one year. A new application for assistance is required for each school year.

Students do not receive full tuition assistance. Students receiving tuition assistance are expected to maintain at least an academic average of "C" or higher in each semester grading period and not pose a discipline problem. The parents are expected to cooperate fully with the teachers and principal. **Tuition assistance is based in part upon a student's previous academic achievement and conduct.** It will continue only if the parents and student continue to meet these qualifications.

READ ALL PARTS CAREFULLY

1. Applications for tuition assistance consist of three (3) parts:
 - A. **Tuition Assistance Application**
 - B. **Copy of Household's Federal Income Tax - 1040 Form for 2020:** This must be complete including all schedules. **Also, attach 2020 Form W-2.**
 - C. **Academic transcripts and conduct reports** (new students) (for grades Kinder through 8) or a letter of recommendation from the last school attended.
2. All information contained in the application is treated with the utmost confidentiality. Please answer all questions fully. **Blank spaces on the application or failure to provide a current tax form and insufficient information will be cause to reject your application.** Additional information that will be helpful is welcome.
3. All items above must be returned as a complete packet to Sister Ann Meletio, 206 W. Convent, Victoria, TX 77901, in a sealed envelope **no later than APRIL 16, 2021.**
4. Notification of Tuition Assistance will be mailed on or about April 26, 2021.
