



## St. Mary Catholic School's 2021-2022 Affordable-Family Tuition Schedule

The chart below represents St. Mary Catholic School's Affordable-Family Tuition Rates for K-8<sup>th</sup> Grade for the 2021-2022 school year, *for new families*. Pre-K tuition rates are at the bottom. A family's actual tuition will be based upon the following:

- 2020 income tax return as filed with the IRS (W-2's, Form 1040, and **All Schedules**)
- If income tax extension is filed for 2020, then your 2019 income tax return as filed with the IRS with a copy of the extension request will need to be provided, pending your 2020 tax return being completed.
- Divorce decree (child support, separate maintenance) and/or State Attorney child support documentation, if applicable
- Social Security Statements, if applicable.

To qualify for categories 1-5, the above referenced documentation must be provided.
