



## St. Anthony Cathedral Basilica School 2020-2021 Sliding Scale Tuition

The chart below represents St. Anthony Cathedral Basilica School's sliding scale tuition for the 2020-2021 school year. A family's actual tuition will be based upon the following:

- 2019 income tax return as filed with the IRS (W-2's, Form 1040, and **ALL Schedules**)
- if income tax extension is filed for 2019, then your 2018 income tax return as filed with the IRS with a copy of the extension request will need to be provided, pending your 2019 tax return completion
- divorce decree (child support, separate maintenance) and/or State Attorney General child support documentation, if applicable
- Social Security Statements, if applicable.

To qualify for categories 1-5, the above referenced documentation must be provided by April 30, 2020. **If you have filed for an extension for your 2019 tax return, your 2019 tax return and your extension request will need to be provided. Your enrollment is not complete until all forms, enrollment fee, enrollment in FACTS (for those paying monthly July – April), and documentation has been received by SACBS.** See the chart below to determine tuition category.
