SJORF will provide booth space according to the size chosen above, including:

- Rental rate covers open to close hours during the entire three (3) day event
- Frontage minimum of one (1) open side with optional canopy / tent style cover
- One (1) 8' folding table and two (2) folding chairs (upon request)
- Lighting and one (1) 110V power outlet (you must supply your own extension cord)
- Two (2) name tags which will allow free parking and access to the school building restrooms.

No booths will be rented after June 30, 2020

RULES AND REGULATIONS:

1. St. Joseph Church nor the Diocese of Youngstown is responsible or liable for loss or damage of any property of second party.
2. Payment must be made payable to St. Joseph Ox Roast Fair to address shown above (non-refundable).
3. Second party is responsible for setting up, attending to, and disassembling booth / display.
4. Set-Up Hours: Strictly between 10:00 AM and 4:00 PM on Friday, July 17th, 2020. ALL SET UP VEHICLES of Second Party MUST be off the fairgrounds by 4:15 PM on Friday, July 17, 2020. ABSOLUTELY NO VEHICLES will be allowed on the fairgrounds after 4:30 PM on Friday, July 17, 2020. Only booths at the \$550.00 rate will be permitted to park vehicles on the grounds during fair hours. These vehicles are not permitted for operation / movement outside of the rented booth area.
5. FAIR IS OPEN RAIN OR SHINE, NO REFUNDS ISSUED REGARDLESS OF EMERGENCY, WEATHER CONDITIONS OR ANY OTHER UNFORSEEN CIRCUMSTANCES. (IT IS STRONGLY DISCOURAGED FOR ANY SECOND PARTY TO PACK UP AND LEAVE BEFORE THE FAIR ENDS FOR THE DAY. IF THERE IS AN EMERGENCY, SJORF WILL UNDERSTAND AND ASSIST IN ACCESS TO BOOTH AREA. AGAIN HOWEVER, NO VEHICLES WILL BE ALLOWED TO ENTER THE FAIRGROUNDS DURING NORMAL FAIR HOURS OF OPERATION)
6. The sale of raffle tickets of any type is NOT permitted by Second Party.
7. No alcohol is to be served, sold or distributed, in any form by any trade / vendor booth during set-up or operating hours of the St. Joseph Ox Roast Fair.
8. An item list of what your booth is selling, displaying or advertising must be submitted with your contract and approved by SJORF Core Committee.
9. Exhibitors may NOT display, advertise, distribute, disseminate, broadcast, or wear any item, printed material, or clothing that is inappropriate, unfitting, or contrary to the teaching and values of the Catholic Church and / or community standards. Determination will be made by the SJORF Core Committee.
10. SJORF reserves the right to decide what items may be sold / displayed at your booth and can cancel the contract for activities or displays that are determined distasteful of contrary to the ultimate community and / or religious sensitivities of the parishioners of St Joseph Church. This determination is made by the SJORF Core Committee.
11. Any violation of these policies or any event, action, display, or person associated with your booth causing harm to patrons will result in forfeiture of rented space for the duration of the fair with no refund.
