

STEPS IN ON PRIORITY PROFITS

Chemicals Raise Chemical Prices 400%, Is Charge

WASHINGTON, Sept. 21—(AP)—The Justice Department, it was learned today, has been asked to take action under the anti-trust law against "priority profiteers" who have raised prices of some chemicals from 100 to 400 per cent. Officials of the price administration said the offending concerns, charging more than two score, employ brokers, many in business for more than a year. Officials are charging exorbitant prices for chemicals essential to the manufacture of drugs, paints, textiles and other commodities. A large part of the business is believed to be in the hands of a few small firms who fear more stringency and who feel compelled to raise prices at any cost.

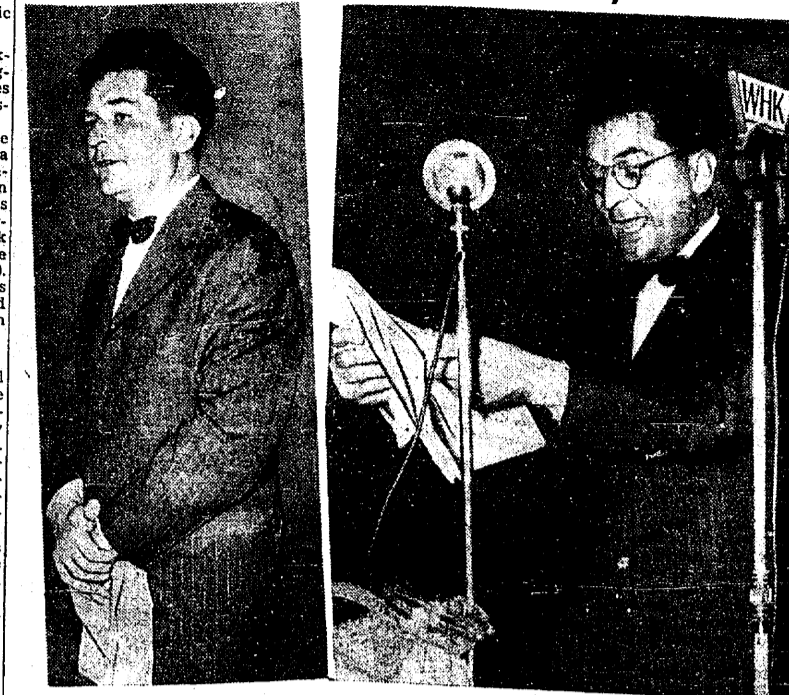

LAUSCHE ASKS \$45 RAIL REFERENDUM

Says Municipal Ownership Is Only Solution in Sight

"Thus far the Cleveland Railway Co. has definitely shown an unwillingness and indisposition to serve the car riders with transportation service that is adequate. To me, the growth of Cleveland and the welfare of the car riders are of the first importance. Adequate service must be provided. Under the present circumstances and considering the history of these negotiations to date, the only solution to the problems appears to be the municipal ownership of the property."
"From my present study and investigation I am not prepared to advise the people of Cleveland that the stock is worth \$45 a share when the stock is selling at about \$27.50 a share on the market and when I, as a citizen, have not been given any better information than has thus far been made available to the people by Mayor Blythin."
"In any event, before this important transaction which shall eventually involve about 18 to 20 million dollars is consummated, I propose that it shall not be done until the citizens by referendum either approve it or reject it on the basis of detailed information to be furnished them."
"It seems that municipal ownership is inevitable, and I submit in all fairness that the accomplishment

of this objective cannot be entrusted to the present administration, surrounded as it is by a majority of Republican councilmen, the leaders of which are bitterly opposed to municipal ownership."
Judge Lausche by implication accused Mayor Blythin of egotism. He cited the mayor's recent assertion that he would give the other candidates "the finest educational course in municipal government they have ever had." He also cited Blythin's comment that former Ohio Supreme Court Judge Arthur H. Day, sewerage if he were to accomplish his promise to end dumping of raw sewage into the lake within one hour after taking office.
"Glib words, wisecracking comments, vain and egotistic appraisal of one's own honesty, sincerity and intellectual attainments, forbode danger to the man who exercises them and calamity to the city if its destiny is to be entrusted to a man of that character," Lausche said.
"I do not pretend to be the possessor of all knowledge on municipal government and law, but I do and shall recognize the seriousness of the duty that I owe to my fellow citizens. When a man boasts about his intellect and makes claims tantamount to infallibility, he is very likely to be smaller in stature than he volubly professes himself to be."
The Democratic candidate charged that millions of dollars had been lost to property owners by fluctuations in property values caused by the failure of the Republican administration of the last 25 years to provide a master plan.
Promising to provide a plan when elected mayor, Lausche charged failure by the city to develop arterial highways, solve the traffic problem and develop the lake front, neglect of park and recreational facilities, "haphazard and costly location" of public buildings and bridges, and failure to study land uses.
Concerning the light plant, he predicted that state examiners would reveal evidence of "criminal negligence or sabotage, or both."
Denouncing the recent formal opening of the addition as a "publicity hoax" because the plant was not yet in production, Lausche contrasted "their oratory with their deeds and actions."
"They opposed building the plant in the first place," he said. "Then they tried to build it uselessly small. In the third place they finally botched and bungled the plans and specifications with a loss of several hundreds of thousands of dollars to the city."
"Why did this administration hire against the better judgment of honest and intelligent Democratic councilmen a Pittsburgh engineer, who, it turned out, did not even know boilers had to have 'steam gauges on them?'
"Why did they mutilate and mar the lake front with further complicated lakefront planning by build-

Members of Precious Blood Society Transferred

Two members of the Society of the Precious Blood took new posts in Cleveland yesterday as assistant pastors of churches under the care of the society.

They are Rev. Leonard Sudhoff, assigned to Our Lady of the Blessed Sacrament Church, 2354 E. 79th Street, and Rev. Frank Uecker, assigned to Our Lady of Good Counsel Church, 4423 Pearl Road S. W. Ask 5-Day Week on State, City Jobs

COLUMBUS, O., Sept. 21—(AP)—The Ohio State Council of the American Federation of State, County and Municipal Employees (A. F. L.) today adopted a three-point program aimed at increasing their salaries and securing a five-day, 40-hour work week.
The council by resolution said its action "is in line with the need to meet increasing living costs by employees of all types."
The resolutions asked:
APPROPRIATION of sufficient funds to increase wages in line with the rising cost of living;
THAT the state and political subdivisions immediately institute a five-day, 40-hour week without a decrease in pay; and
"WHEREAS it is estimated that there will be a surplus of \$25,000,000 in the state treasury "it is resolved that Gov. (John W.) Bricker immediately call a special session of the legislature to increase wages of state employes and allocate sufficient funds to political subdivisions to make possible wage increases to employes."
The council elected these officers: President, Earl Catton of Toledo; secretary, Miss Mary Burke of Cleveland; treasurer, Alvin Garlock of Lima.
