The goal of Good Shepherd Catholic School Athletic program is to give students the opportunity to have fun while learning how to play a sport(s); to promote physical fitness; and to instill the values of good sportsmanship, fair play and teamwork.

1. The Good Shepherd Catholic School Athletic Booster Club has the right to regulate the participation of students in Good Shepherd Catholic School athletic activities and ensure that the Booster Club by-laws are followed.
2. Payment of the sports fees must be provided before the dates above. A student athlete will not be able to participate after the date if fees are unpaid. If you have a financial burden, please contact the Athletic Director prior to submission.
3. All student athletes should have a Sports Physical documented on KHSAA Form MS01 before beginning practice/play which should be completed within the past 12 months.
4. A student enrolled in Good Shepherd Catholic School may participate on Good Shepherd Catholic School sponsored athletic teams. Home school students of Good Shepherd Parishioners may also participate on Good Shepherd Catholic School sponsored athletic teams if sport specific league rules allow. Students from other schools may also participate on Good Shepherd Catholic School athletic teams at the discretion of the Athletic Director.
5. Parents/Guardians of student athletes **are expected** to assist at Good Shepherd Catholic School sponsored athletic events. Every Parent/Guardian is expected to assist at least twice per year.
6. A student is eligible to practice/play if the student has satisfactory grades. Satisfactory grades are defined as a **"C" or better in each subject area** (determined by the overall average for that class rather than the grading period average). Grades will be checked weekly and the student, parent/guardian, coach will be notified of ineligibility. Ineligibility takes effect immediately upon notification. A student remains ineligible until the next grade check. If the grades are deemed satisfactory at a subsequent check, they will be notified and become eligible immediately. "C" average or better in each class = ELIGIBLE; D or F in any class = INELIGIBLE.
7. A student's eligibility is also based on conduct. The Principal, Athletic Director, Athletic Booster Club or Coach may declare a student ineligible for poor conduct. Poor conduct may include but is not limited to disrespectful behavior, destruction of property, or fighting.
8. A student may lose eligibility if they receive 5 white slips in a semester.
9. A student that is absent from school due to illness or has an unexcused absence for half of the school day or more may not dress in uniform or sit with the team that day.
10. A student that is suspended from school may not practice or play during the suspension. The student may begin practicing when they return to school but will be ineligible for the first game after their suspension.
11. Coaches will determine the amount of playing time that each student receives.
12. If a student misses two practices in one week, Monday through Saturday, the student may not be able to play the first half of the first competition that the student attends. The rule does not apply when:

- a. A student misses practice due to a School sponsored event.
  - b. A student misses school and practice due to an illness and the absence from school is excused.
  - c. Students should inform their Coach if they are presently participating in other Frankfort sports through the YMCA or other organizations and have a conflict between schedules. Such students will be exempt from this rule during the conflict.
13. Uniforms and equipment are assigned to students on a loan basis for the duration of that sport's season. It is the responsibility of the student to maintain the equipment and uniform that they are loaning. Uniforms and equipment are expected to be returned in the same condition as when they were assigned. The student is financially responsible for lost, stolen, missing or damaged uniforms or equipment.

# Good Shepherd Catholic School Sports Discipline Policy

This Discipline Policy applies to Students, Parents and Coaches present at any Good Shepherd sponsored athletic practice, game or event. This policy may be enforced by Coaches, the Principal, Athletic Director or Athletic Booster Club.

A Category One Offense will result in a Verbal Warning.

The following are Category One Offenses:

- excessive dissent with an official
- disruptive to team at practices or competitions
- disregard of facilities

A Category Two Offense will result in an ejection.

The following are Category Two Offenses:

- two Category One offenses in the same season
- cursing, abusive or foul language
- unsportsmanlike conduct

A Category Three Offense will result in an ejection followed by a one game suspension.

The following are Category Three Offenses:

- verbal abusive of a student, coach, parent or official
- physical intimidation
- being ejected from an event

A Category Four Offense will result in an immediate suspension from the team. All Category Four offenses will be evaluated by the Principal, Athletic Director or Athletic Booster Club to determine future eligibility in Good Shepherd Athletics.

The following are Category Four Offenses:

- fighting
- destruction of facilities
- two Category Three offenses

The listed offenses are not an all-inclusive list. Offenses not listed in this policy will be evaluated to determine the Category in which they fall.
