Late Re-Registration after May 15, 2021 for returning families will incur a \$50 Fee and after May 28, 2021 will forfeit their YES Tuition Rate unless we receive a verbal or written commitment by May 28, 2021 to reenroll by July 15, 2021 for their 10-month plan (otherwise children will be subject to the 2021-2022 YES Tuition Rate).
