KINDERGARTEN - WITH THE EXCEPTION OF THE 1 PAYMENT PLAN, ALL SHADED AREA PAYMENT AMOUNTS ABOVE ASSUME THAT THE \$500 REGISTRATION FEE HAS ALREADY BEEN PAID AT REGISTRATION.

- 1) KINDERGARTEN STUDENTS WITH SIBLINGS IN "GRADE SCHOOL" (NOT PRESCHOOL) ARE ENTITLED TO A \$500 DISCOUNT OFF OF THE ANNUAL TUITION RATE SPECIFICALLY AS PER THE TUITION SCHEDULE ABOVE. THE DISCOUNT CANNOT BE USED FOR THE NON-REFUNDABLE DEPOSIT. SEE ABOVE.
- 2) KINDERGARTEN - THE 2 PAYMENT PLAN, 4 PAYMENT PLAN AND THE 10 PAYMENT PLAN TUITION COSTS SHOWN IN THE SHADED AREAS ABOVE ARE ALL "IN ADDITION TO" THE INITIAL \$500 DEPOSIT. HOWEVER, THE "ANNUAL" TUITION AMOUNTS SHOWN ABOVE DO INCLUDE THE \$500 DEPOSIT.
- 3) THE 1 PAYMENT PLAN IS DUE IN FULL ON AUGUST 1ST OR AT SCHOOL REGISTRATION, WHICHEVER IS LATER. HOWEVER, FOR KINDERGARTEN, THE REGISTRATION FEE (DEPOSIT) IS ALWAYS DUE AT SCHOOL REGISTRATION.
- 4) THE 3% DISCOUNT APPLIES ONLY IF ALL FOUR QUARTERLY PAYMENTS ARE MADE ON TIME. OTHERWISE, THE "LATE QUARTERLY PAYMENTS" OR, THE "NORMAL TUITION" AMOUNTS NOTED ABOVE WILL APPLY TO ALL FOUR QUARTERS AND THE SMART TUITION BILLING WILL BE ADJUSTED ACCORDINGLY.
- 5) THE MONTHLY 10 PAYMENT PLAN IS ONLY AVAILABLE TO FAMILIES THAT AGREE TO GIVE SMART TUITION THE AUTHORITY TO MAKE ACH DEBITS. THIS PAYMENT PLAN ARRANGEMENT WILL BE CANCELLED AND THE NORMAL TUITION RATE WILL APPLY IF THE ACH DEBIT AUTHORITY IS CANCELLED.

IF YOU HAVE USED BILL PAY IN THE PAST, PLEASE UPDATE BOTH YOUR FAMILY ID NUMBER (ACCOUNT #) AS PER ABOVE AND YOUR PAYMENT AMOUNT(S) TO REFLECT THE INCREASED TUITION OBLIGATION.

NOTE THAT BANK FEES OF APPROX 2.85% WILL APPLY IF YOU USE A DEBIT CARD OR CREDIT CARD AND THEIR USE IS THEREFORE DISCOURAGED.

BANK FINANCE FEES, BANK FAILED FEES, AND LATE PAYMENT FEES ARE ADDED TO THE TUITION COST AND ARE THE RESPONSIBILITY OF EACH FAMILY.

USING BILL PAY, CHECKS, OR AUTHORIZING DEBIT PAYMENTS BY PROVIDING SMART TUITION WITH YOUR BANK AND ROUTING NUMBERS (WHICH ARE PRINTED ON YOUR CHECK ANYWAY) ARE ALL FREE.

*** SEMI-ANNUAL MINIMUM PAYMENT REQUIREMENTS:

- 1) SCHOOL ADMISSION WILL NOT BE PERMITTED IN SEPTEMBER UNLESS EITHER 50% OF THE ANNUAL TUITION HAS BEEN PAID (PLUS THE DEPOSIT IF APPLICABLE), OR SPECIAL PAYMENT ARRANGEMENTS HAVE BEEN MADE WITH THE PARISH BUSINESS MANAGER BEFORE AUGUST 8TH (PLEASE REFER TO THE SCHOOL TUITION POLICY FOR DETAILS).
- 2) SCHOOL ADMISSION WILL NOT BE PERMITTED IN JANUARY UNLESS EITHER 100% OF THE ANNUAL TUITION HAS BEEN PAID, OR SPECIAL PAYMENT ARRANGEMENTS HAVE BEEN MADE WITH THE PARISH BUSINESS MANAGER BEFORE DECEMBER 8TH (PLEASE REFER TO THE SCHOOL TUITION POLICY FOR DETAILS).
