

## ACED FEE SCHEDULE 2021 - 2022



Registration Fee – per child <sup>1</sup>	\$50.00/Child
Security Access Fob Fee <sup>2</sup> (Only applies to newly issued fobs)	\$10.00/Fob
Part-Time Flexible Plan <sup>3</sup> Applies to Morning, Afternoon, Half- and Full-Days <sup>4</sup>	\$5.00/Hour
Full-Time (Includes Mornings, Afternoons, and Half-Days) <sup>5, 7</sup>	\$250/Month
Full-Time PLUS (All Inclusive: Mornings, Afternoons, Half-Days and Full-Days) <sup>6, 7</sup>	\$280/Month
Late Fees, Charged per minute, per child, after 6:00 p.m. <b><i>Applies to ALL families</i></b>	\$1/Minute

### Explanation:

1. An annual Registration Fee is charged per child, at the time of registration. If a student enters the ACED program after the 1<sup>st</sup> Quarter, the registration fee may be prorated based on the quarter during which attendance began, as follows: 2<sup>nd</sup> Quarter - \$40; 3<sup>rd</sup> Quarter - \$25; 4<sup>th</sup> Quarter - \$10.
2. Security access fobs are needed to enter the school building when picking up children after school hours. Each person picking up children on a regular basis must have a fob. The \$10 fee is charged when a fob is issued. Families who keep their fob(s) from year to year will not be charged in subsequent years.
3. All Part-Time ACED charges are based on the rate of \$5/hour. The charge is pro-rated by rounding up to the next quarter hour. For example, 1 – 15 minutes of care would be charged at \$1.25; 16 – 30 minutes of care would be charged at \$2.50; 31 – 45 minutes of care would be charged at \$3.75; and, 46 – 60 minutes of care would be charged at \$5.00.
4. Noon Dismissal Half-days are capped at \$25. No School Full-days are capped at \$50.
5. \$250 is the monthly rate for one child. Additional siblings registered as Full-Time receive a 20% Discount, and are charged the rate of \$200/month/sibling. ***This rate does not include Full Days.*** Any Full Days attended will be charged at the Part-Time rate.
6. \$280 is the monthly rate for one child. Additional siblings registered as Full-Time PLUS receive a 20% Discount, and are charged the rate of \$224/month/sibling.
7. August 2021, December 2021, March 2022 and May 2022 will be prorated months for Full-Time and Full-Time PLUS families as follows:
  - ◆ August 2021 – The regular monthly rate will be discounted by 50%.
  - ◆ December 2021 – The regular monthly rate will be discounted by 25%.
  - ◆ March 2022 – The regular monthly rate will be discounted by 25%.
  - ◆ May 2022 – The regular monthly rate will be discounted by 25%.
8. If school is mandated to be closed for health reasons, ACED will also be closed. In that event, Full-Time rates will be prorated accordingly.
