DISCUSSION / ACTION ITEMS

- 1) Call meeting to order, prayer;

Public Comments: Members of the public may collectively address the Board for a total of thirty minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda (i.e. the public comment section of the meeting). Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public may collectively address the Board for a total of thirty minutes per item on the agenda. Members of the public will speak on an agenda item after comments on the item is called for by the presiding officer, but before Board discussion and consideration of the item. Speakers will be called upon in the order that they signed up to speak on an item. If more than ten speakers sign up to speak on an agenda item or as part of public comment on items not on the agenda item, each speaker's allotted time will be proportionally reduced to allow all speakers an opportunity to speak within the 30-minute time limit.

- 6) Review, discuss, and vote on new ambulance purchases with Equipment – All Commissioners
- 7) Review and discuss the Chief's monthly report, – All Commissioners
- 8) Review proposal for repairs to Station 2 drainage, vote on action(s) – All Commissioners
- 9) Review, discuss, and approve ESD 1 2022 budget – All Commissioners
- 10) SAFE-D Conference update – Tyne Trevino
- 11) Receive and discuss progress reports from the BSBES board and standing ESD committees, – All Commissioners
- 12) Discuss goals for SAFE-D meeting in September – All Commissioners.
- 13) Adjourn and set next meeting for 21 October 2021, – All Commissioners.

Board decides to enter executive session regarding any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and the provision from the Open Meeting Act that authorizes the closed or executive session.
